II. REQUESTS FOR BIDDER INFORMATION

1. Thern will not quote their crane without specs on the components desired. Do you have specs or ratings we need to meet?

Response: The desired Thern Selection is as follows: Model 5PT5-M1 up to 650 lb capacity with M4042PB-K spur gear hand winch – powder coat crane and Model 5BP5 Powder Coat Pedestal base. In addition, provide ¼" diameter, 20-foot long, 304 stainless steel wire rope (Model No. WS25-20NS).

2. The following questions were asked regarding "Article 19 ARP Guidelines" in "Section 00 73 00 Supplemental General Conditions" in the Contract Documents and Specifications: What is meant by preference and practicable? Are domestic materials required or preferred?
