The Project consists of repainting and repairs of a 10-million-gallon prestressed concrete wastewater detention reservoir.

All bidders must be licensed Contractors in compliance with all requirements of the State of Tennessee Contractor's Licensing Act. Bidders must be listed on Engineer's list of planholders who have purchased the Contract Documents and Specifications.

The allotted time for construction is to be ninety (90) consecutive calendar days (15 days for shop drawings and materials procurement and 75 days for work on site).
